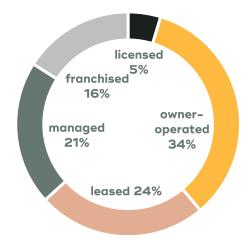

- > With over thirty openings in 2022, mid-scale and luxury are the most dominant segments represented.
- > The main Italian cities for the new openings are not only the Bia Four -Rome, Venice, Milan, and Florence - but also leisure destinations such as Cortina d'Ampezzo, Apulia, Sicily, Umbria and Tuscany. Alternative attractive cities are Trieste, Genoa, Naples and Bari that have aroused the interest of big international brands like NH Hotel Group, Meliá, Hilton, and Radisson Hotel Group.
- > Compared to the previous year, a general increase between 5% and 10% in hotel real estate values throughout the country is expected. Consequently, an overall increase in hotels and demand is foreseen
- > Based on STR's projections, this year's business on the book is growing compared to last year. This trend is not only seen in well established leisure destinations, but also in cities such as Matera and Turin.
